REFERENCE: ASSISTANT SECRETARY OF DEFENSE MEMORANDUM, DATED SEPTEMBER 22, 2002, SUBJECT: FISCAL YEAR 2003 CLOTHING MONETARY ALLOWANCES.

1. THE PURPOSE OF THE MESSAGE IS TO PROVIDE DEFENSE MILITARY PAY OFFICES (DMPO'S), DEFENSE ACCOUNTING OFFICES (DAO'S), AND FINANCE OFFICES (FO'S) THE NEW CLOTHING ALLOWANCES EFFECTIVE OCTOBER 1, 2002.
2. THE NEW CASH REPLACEMENT ALLOWANCES (ANNUAL RATE) EFFECTIVE OCTOBER 1, 2002, ARE AS FOLLOWS:

3. THE FEMALE CASH ALLOWANCE FOR FY 2003 IS \$303.93. THE MALE CASH ALLOWANCE FOR FY 2003 IS \$60.78. THESE ALLOWANCES SHOULD BE PAID IN ACCORDANCE WITH THE DEPARTMENT OF DEFENSE FINANCIAL MANAGEMENT REGULATION, VOLUME 7, PART A, (DODFMR, VOL 7A), PARAGRAPH 290205.
4. THE NEW RATES FOR CIVILIAN CLOTHING ALLOWANCES ARE:
 - A. THE NEW PERMANENT DUTY CIVILIAN CLOTHING ALLOWANCE IS \$822.03
 - B. THE NEW REPLACEMENT PERMANENT DUTY CIVILIAN CLOTHING ALLOWANCE IS \$274.01.
 - C. THE NEW TEMPORARY DUTY CIVILIAN CLOTHING ALLOWANCE IN EXCESS OF 15 DAYS BUT LESS THAN 30 IS \$274.01.
 - D. THE NEW TEMPORARY DUTY CIVILIAN CLOTHING ALLOWANCE OVER 30 DAYS IS \$548.02.
